The fight for a fair Unemployment Compensation bill is not over!

Last month, Labor rallied, and Scott Perry's House Bill 916, which would drastically cut unemployment compensation benefits, failed to move forward. Now we face a new challenge. Today, the House Labor & Industry Committee amended Senate Bill 1030, adding several of the provisions that were contained in Rep. Scott Perry's HB 916.

The Pennsylvania AFL-CIO **OPPOSES** this bill as it was amended by the Committee. The fight needs to continue on the House Floor where Rep. Gene DiGirolamo will offer amendments that bring SB 1030 back to being a reasonable bill.

We need everyone to contact the following Republican Representatives and urge them to SUPPORT Rep. DiGirolamo's amendments and/or motions. These Representatives have stood with us on this issue, and we need them to continue to fight to protect Pennsylvania's unemployment compensation program.
